For those of you that are new to our parade, our event continues to grow bigger and better each year and we would like to welcome you aboard. We anticipate having one of the "best" parades ever with **line up beginning at 8:30 a.m. and step off at 10:30 a.m. SHARP!**

Some of the other Cottage Grove Strawberry Fest events will include a carnival, live music, car show, fireworks, softball tournaments, kids pedal tractor pull, top chef contest, pie eating contests, pet show, business expo, talent show and NFL Punt, Pass and Kick competition.

Enclosed are the parade entry, waiver and agreement forms. Please complete the forms and return them with the application fee by May 21, 2012. A \$25.00 late fee will be charged for applications received after May 21, 2012. Refunds will be granted with a written request if received by June 1, 2012. No other refunds will be issued for any reason. **Line-up information will be available approximately two (2) weeks prior to the parade via our web-site.**

Again this year: Judging for parade units will take place prior to the parade beginning at 9:00 a.m. Judging for the parade entries will take place in the parade lineup area and awards will be given out prior to the start of the parade. Please be on or at your unit no later than 9:00 am. If the judges reach your unit and you are not there, you will not be judged. Judging will be completed by 10:00 am. A trophy will be presented along with an award banner and two volunteers to walk in front of the winning entries during the parade. Parade awards will be given for Mayor's Choice, Judge's Choice, Most Creative (First, Second, and Third Place) and Best Local Entry.

Cottage Grove Strawberry Fest Waiver and Agreement

I/ we as members and representatives of the undersigned unit/ organization have agreed, for our benefit, to participate in the Cottage Grove Strawberry Fest Parade. By doing so, I/we agree to the following requirements:

Cottage Grove Strawberry Fest, Parade Director and other staff, volunteers and members will be held harmless against any misfortunes that may arise. Including but not limited to personal injury to myself or others in my organization, damage or loss of any property belonging to myself or those in my organization.

I/ we hereby waive and release any claim we have or may have in the future against the Cottage Grove Strawberry Fest, Parade Director, committee members and volunteers. Furthermore I/ we release any claim for any other damage that I/ we might sustain, whether or not caused in whole or in part by the negligence of such officers, directors, partners, and volunteers, which occurs during or as a result of our participation in the Cottage Grove Strawberry Fest Parade.

Furthermore, I agree that myself or anyone operating a vehicle in the Cottage Grove Strawberry Fest Parade or in conjunction with the event has a valid driver's license or drive such a vehicle and is accompanied by the appropriate vehicle and liability insurance.

I/ we understand that the pertinent parade line up information will be provided to me/ us approximately two (2) weeks prior to the event on our websites. I/we understand that if we arrive for line up late that we forfeit our position in the line up and will be placed within the line up at the discretion of the director, at the end, or not at all.

I/ we agree that there will be no use of Alcohol, Fireworks, Explosives or any other items that may be considered illegal, dangerous, or inappropriate for a public event. Furthermore, we understand that the Cottage Grove Strawberry Fest Parade Director and his/her representatives are the final authority in decisions of appropriateness and we agree to abide by his/her decisions.

Finally, I/ we agree to and will uphold the rules set forth by the Cottage Grove Strawberry Fest Parade Director, including but not limited to, parade units and the laws regarding consumption of alcohol by drivers, passengers, or unit participants during line up, on the parade unit, along the parade route or at the end of the parade.
